Parent/Guardian Responsibility: It is the responsibility of each parent/guardian to understand the policies and procedures for the Revere Local School District Full Day Kindergarten Program prior to registering their child.

Admission to the Program:

To apply for the full-day program you must be fully enrolled into Revere Local Schools and submit the following documents/fees:

- Step 1: Complete On-Line Enrollment through 'Final Forms' (will be available Mid-March 2021) (www.revereschools.org – parents & students – New Student Registration)
- Step 2: In-Person Registration Appointment – Parent/Guardian to provide Required Enrollment Documents
- Step 3: This 'Tuition Agreement' signed by a custodial/residential parent/guardian; and First Month's Tuition/deposit; check/money order for \$300.00 *made payable to 'Revere Local Schools'*

The following forms must be submitted within 30 calendar days of the first day of school or you will forfeit your child's spot in the full day program in addition to the first month's tuition:

- Physicians Report

Terms/Waitlist: All Tuition Agreements (a.k.a. Applications) require a \$300.00 non-refundable deposit. In the event a family signs up for Full Day Kindergarten and does not receive a slot for their child, the "non-refundable" deposit will be refunded and placed on a numbered waitlist. Availability of slots is determined by District Administration. If space allows, wait-list families will be offered the full day option, in wait-list order.

Withdrawing Child From Program: If, at any time after acceptance into the program, a parent/guardian decides to withdraw from the program, written notice of withdrawal must be given by parent/guardian to the Registrar two weeks in advance of the child's last day of attendance. Without written notice of withdrawal, it is understood that the child will be considered enrolled and the parent/guardian's obligation to pay tuition shall continue. If the school year has begun, a discussion will take place with the building principal to ensure the transition to a half-day is appropriate. No changes from Full Day placement to Half Day will be honored after October 2, 2021.

If a student is withdrawn from the Full Day Program, the parent will be responsible for the pro-rated tuition for the period of enrollment to the end of the month. If applicable, the remainder of the school year's pre-paid tuition will be refunded. This also includes families moving out of the Revere School District.

Holidays and Other Breaks: During the school year, the program will follow the school calendar adopted by the Board of Education unless the parents are notified differently.

Programming: This contract does not create any additional rights for the Student or his/her Parent, other than attending the Program, nor does it create any additional obligations or responsibilities for the District, other than providing the Full Day Kindergarten Program described herein. The District retains all rights with respect to the discipline and education of the Student and expressly retains the right to suspend or expel the Student from the Program for any cause permitted for suspension or expulsion of the Student from the regular Half-Day Kindergarten Program.

Tuition Fees: The tuition for the 2021-2022 school year is \$3,000.00. The parents will be credited for the non-refundable initial deposit of \$300.00 and applied to the total cost of tuition (September payment). The balance of the tuition shall be paid in nine (9) additional monthly installments, \$300.00/month, due the First (1st) of each month; October 1, 2021 through June 1st, 2022 and payable through EZpay or check.

Failure to make the payment by the required date may result in student being removed from the Program until payment of all fees is brought current.

Parent hereby understands that the District reserves the right to take such action under law as it deems necessary to collect fees under this contract, including, but not limited to, denying attendance in the Full-Day Program. If a fee payment is not received by the 5th day of the month of payment, commencing on the next school day the Student may not be allowed to attend the Program until payment of fees is made current. Exclusion from the Program for failure to pay fees does not release or diminish the obligation of parent to pay the participation fee. The District shall have no right to deny the Student the regular, non-fee half-day kindergarten program on any failure of parent to perform its obligations hereunder.

Payment/EZPay: Tuition & General Fees: Prior to August 1st, 2021, tuition must be paid by check or money order, payable to “**Revere Local Schools**”, sent Attn: Treasurer’s Office, Revere Local School District, 3496 Everett Rd, P.O.Box 340, Bath, OH 44210-0340.

After August 1st, 2021, **EZPay** will be available and is the preferred method for payment. The EZpay system, through our District Website, allows you to make full or partial secure payments on-line using a credit or debit card. It is the same system used for school lunches. Information and a user guide on how to use this system is posted on the district website. Student ID numbers will be mailed home prior to July 23, 2021.

Parents will be assessed a late fee of \$25.00 (if more than 30 days overdue) and a separate additional fee of \$35.00 per NSF item for checks or credit card payment rejection (unless caused by bank or district error).

Early Payment Bonus: An Early Payment Bonus will be applied to those students who have ‘Paid in Full’ prior to September 10, 2021 AND have completed the Full Day Kindergarten Program through the end of the academic school year.

If you are ‘Paying in Full’ through EZpay and wish to receive the discounted rate, DO NOT PAY the ‘JUNE 2022’ Tuition. Upon review of your account, we will waive the aforementioned payment.

Multiple Child Discount: Families with more than one student enrolled in the full-day program for KG in the 2021/2022 school year, a 10% discount will be applied to the second and subsequent child’s tuition.

General Fees: The Tuition Fee, as stated in this agreement, is separate from the annual ‘General Fees’ that are assessed for student’s workbooks and materials, etc..

Refunds: There are no refunds for missed classes due to illness, vacations, field trips, holidays, calamity days or any other time your child does not attend classes.

Tuition Reduction: Families may qualify for a reduction of tuition using the Federal Lunch Program's income guidelines (<http://education.ohio.gov>). Students who qualify for a fee waiver or reduction are subject to the same enrollment requirements as all other applicants (i.e. lottery, wait-list, on-time payments, etc.). A separate eligibility form must be submitted to the district Registrar. Forms will be posted to our website when they become available. To qualify, you must meet the Federal Income Guidelines for the "Free or Reduced" Income Scale that is based on Gross Federal Income. A copy of your 2020 tax returns must be submitted along with the application. Monthly payments will be pro-rated if approved. Additional information is on the separate form.

There is an 'Early Payment Bonus' Option (per student) if Paid in Full by September 10, 2021 (One Month's Tuition will be waived)

There is a separate scale for Tuition Assistance, based on household income - see separate application to see if you qualify.
